I have most of the Census information for Ellerker from 1841 to 1901 and it is intriguing to see that in 160 years the number of dwellings in the Parish has increased 80%, from 70 to 126, but that the number of people has reduced from 373 to about 290.


If these questions and the answers to them interest you, please give me a call (422585) and we'll see if together, we can form an Ellerker Local and Family History Group.

Parish Council

Planning – Applications have been received for the following developments:

- Pear Tree House, Sands Lane 2 storey extension - Approved
- Micawber Cottage, Church Lane dormer extension, garage alteration and conservatory – Refused
- 3) Sands Lane erection of T-Mobile phone mast Withdrawn
- Brantingham Road erection of Gridcom mobile phone mast Permitted Development (the Council has



- 5) Wold View, Ring Beck Lane change of use of outbuilding to 'Industrial' Awaiting Decision
- 6) The Bungalow, Main Street 2nd storey extension, integral garage and conservatory Awaiting Decision
- Keeper's Cottage, Dale Road, Brantingham – additional access road and erection of six 'Walker's Lodges' - Awaiting Decision. NOTE. This is also to be considered by Brantingham Parish Council.

2003 Election – nominations for the Council will be required in time for the forthcoming election, which will take place 1st May 2003. It is hoped that sufficient nominations are sent to ERYC to enable a 'proper' election to take place.

Village Hall Hire Fee – It has been accepted that the Village Hall finances demand that a large increase in hire fee for Parish Council meetings is inevitable. As with other changes in costs, it will have to be reflected in the Parish Precept, collected as part of Council Tax.

Finance – Due to election expenses and increases in costs for training, internal audit, Clerk's salary and Hall hire, budgeted expenditure for the coming year is due to rise by £240. To accommodate this a 15% increase in the Parish Precept was indicated, however, it was decided that half the increase should be drawn from reserves.

Standing Orders – The new Model Standing Orders have been adopted by the Council

Black Horse – it was noted that the proprietors of the Black Horse Restaurant had written to the Playing Field Committee questioning the position of equipment near their mutual boundary. It was agreed that any dispute would be between the two parties and would not involve the Parish Council.

Clerk's Salary – this is being reviewed in the coming year in line with national recommendations. It was agreed by all that the present Clerk does an excellent job. **Stonepit Road** – Concern was expressed at the mud on the road at Willow Flats and at the landfill activity, taking place at the ex-ERYC depot. Although on the Ellerker side of the A63, this site lies within South Cave Parish and questions can be addressed to them via their office in Market Place.

Allotment – the cost of cutting back the hedge to reasonable height is being sought. The request for the Council to provide a water supply has been turned down.

Freedom of Information – the Council is taking steps to comply with this requirement, which seeks to make the Council more open to scrutiny of their decision making. All 'Core Classes' have been adopted, extensions can be considered later. More about how to access information held by the Parish Council, will be published in the next issue of Ellerker News.

Miscellaneous – the Council has expressed dismay at the delay in improvements to the South Cave interchange – Yorkshire Electricity will be working in the village, to prune trees which may interfere with their power lines – the Clerk will coordinate a working party to implement annual maintenance of Council assets – it was noted that hedge height had been reduced at the Wandahome site, contrary to the Council's request at the time 'change of use' was requested.

A little bit of Ellerker history

New government taxes have never been popular. The riots that followed the poll tax of 1990, the introduction of income tax during the Napoleonic wars, and Lloyd George's land tax in 1911, that caused a constitutional crisis, are just three examples. But it was the hearth tax imposed by Charles II's Parliament in 1662 that created widespread public condemnation and riots in Bristol and London. The tax was based on the number of hearths in a building and for Ellerker in 1672 there were 88 hearths recorded in 55 buildings. Ten buildings were exempt "discharged by legal certificate" and eight had more than two hearths, with Mr Wm. Towlyn having 6 and Mr Ellerker 4. The tax records were an early form of the current census.
