Scams continue to be a problem generally. The latest scam involves the NHS Test and Trace system. If NHS/ Trace contact you they will be using the following number: 0300 0135 000 If you receive a call from any other number then please do not hesitate to contact Action Fraud on 0300 123 2040.

If you are contacted, genuine contact tracers will never ask the following questions.

- 1.To dial a premium rate number (09 or 087)
- 2. To make any form of payment
- 3. Bank details
- 4. For social media login details
- 5. For passwords, pin numbers or for you to set them up over the phone.
- 6. To buy a product.
- 7. To download any software to your device or to hand over control of your PC, Smartphone or Tablet.
- 8. To access any website that does not belong to the government or NHS.

Parish Council News

The Parish Council met virtually on the 7th and 28th May 2020. Due to the Covid 19 pandemic it has not been possible for the Parish Council to physically meet to facilitate the Annual Council and Parish Meetings when groups from the Parish are invited to share details of activities completed in the past year and plans for the next 12 months.

The Annual Parish Meeting will be facilitated when possible. Minutes of both meetings are available to view on the Ellerker Parish website.

Claire Wood was requested at the meeting on the 7th May 2020 to undertake the post of Chairman of the Parish Council for the next 12 months. Claire presented her 5th Annual Report as Chairman of Ellerker Parish Council. The Council has met in the last 12 months and there have been 2 meetings of the Personnel Committee. The Parish Council also hosted several community meetings for different purposes; engaging residents with special

knowledge, other village committees and the wider community.

The Annual Governance and Accountability Return (AGAR) for the year ending 31 March 2020 was approved by the Parish Council at the meeting of the 28th May 2020. The dates set for the period of exercise of public rights commences on 15th June 2020 and ends on 24th July 2020. During this period the Annual Governance Statement and Accounting Statements for 2019/20 will be available to view on the Parish noticeboards and the website.

Ellerker has been a popular venue for cyclists and walkers during lockdown. New notices have been erected reminding exercisers that the public footpath at the top of Cockle Pitts must not be used by cyclists. Apart from being against the law, the footpath has become eroded over the past weeks.

Work will be undertaken in the next few weeks to preserve the Bus Shelter at the top of Howden Croft Hill. Prior to the application of weather resistant stain, all loose decoration which has been previously applied will to be cleared, ready for the application of a new coat with the colour to suit existing.
